# Nature conservation and livelihoods in the KAZA TFCA

- Some 3m people live in the KAZA TFCA
- Human-wildlife conflict is widespread
- Protected areas and wildlife dispersal areas complicate livelihoods and rural development
- KAZA committed to livelihoods support, coordinated through national policies and programmes





# **KAZA livelihoods framework**

- Reinforces KAZA's commitment to sustainable rural livelihoods
- Effective transfrontier conservation impossible in a context of poverty
- Focus on livelihoods adversely affected by nature conservation
- A SADC programme under auspices, and in support, of national authorities

# KAZA support for community water infrastructure

- Collaboration and funding being negotiated with CRIDF
- Namibia first; then Zimbabwe; possibly other countries (Zambia, Angola...?) later
- Focus on basic human needs and associated livelihoods support for communities affected by HWC





#### **Preparatory activities**


- Site selection in consultation with Hwange Rural District Council, chiefs and other community leaders
- Scoping visits, March and July 2014
- Technical design mission, March-April 2015
- Consultation with Government of Zimbabwe, Harare, 9 October 2015:
  - Department of Environment
  - Department of Climate Change

#### Proposed work at each site

- Note that these are preliminary plans, still subject to final design, feasibility check and funding approval
- Borehole(s) with solar pump
- Communal standpipe(s)
- Reticulation to cattle trough(s)
- Small fenced vegetable garden for group operation with hoses or drip irrigation

#### **Environmental screening**

- Has been carried out as required by CRIDF procedures and in line with national legislation
- No major challenges identified
- Concluded that no permits would be needed unless borehole proposed in forest area near Simkhulule

UK AID FROM THE BRITISH PEOPLE

 Dam rehabilitation would need more detailed investigation and approvals. Not proposed at this stage.



# Proposed implementation arrangements

- Seek and secure funding
- Series of construction/installation contracts
- 12-month Community Health and Food, Agriculture and Nutrition Club programmes at each site
- Certification and hand over of boreholes, pumps and reticulation

- Funding source: to be identified
- CRIDF facilitation and monitoring of funding and implementation
- KAZA implementation under auspices of HRDC and MEWC
- Hand over to Community Health Clubs
  under auspices of HRDC
- KAZA and HRDC monitoring

#### **Proposed next steps**

- Identify, negotiate and confirm funding
- Ongoing liaison with local authorities through KLO
- KAZA procures supervisors and contractors in consultation with HRDC and CRIDF
- Installation and Community Health/Food, Agriculture and Nutrition Clubs start

- Under auspices of MEWC and in line with its livelihoods framework, KAZA will continue support for sustainable rural livelihoods in areas affected by wildlife and conservation
- If this initiative succeeds, further support for water infrastructure and related developments is not excluded
